Prevention and conduct

Recommended safety measures for handling the <u>undiluted</u> product:

Appropriate engineering controls: Provide a good standard of general ventilation.

Avoid direct contact and/or splashes where possible. Train personnel. Users are advised to consider Appropriate organisational controls:

national Occupational Exposure Limits or other equivalent values, if available

Personal protective equipment Eye / face protection: Safety glasses or goggles (EN 16321 / EN 166).
