Duni declares that the article meets the requirements of:

- Article 3, 11(5), 15 and 17 of Regulation (EC) No 1935/2004 (Framework regulation)
- EU Regulation 2023/2006/EC (GMP)
- EU Regulation 10/2011/EC with amendments (Plastic regulation)
- EU Regulation (EU) 2024/3190 on the use of bisphenol A (BPA) and other bisphenols

This plastic product has been manufactured only with monomers, other starting substances and additives that are authorized under Regulation (EC) 10/2011 and all amendments. A risk assessment according to Article 18 and Article 19 of Regulation (EC) No. 10/2011 has been performed for this product.

### Overall migration (1)

According to the above mentioned regulations, the overall migration does not exceed 10 mg/dm<sup>2</sup> or 60 mg/kg.

### Specific migration (2)

One or more of the substances are subject to specific migration limits. All restricted substances have undergone migration testing, and the results confirm compliance with the applicable limit values.

### Area of use

Based on the migration tests and Declaration of Compliance in Duni's possession, the articles can be used safely with all types of foodstuffs, serving cold and hot. The articles can be used for storage in chilled conditions and temperatures up to 2 hours at 70°C.

The boxes are not suitable to use in microwave oven.

**Product safety**

Migration tests on the material of the article performed by an independent institute showed that under the following test conditions overall migration and specific migration fall below the respective limits given by regulation 10/2011.
